6 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODCREEK, TEXAS,**
7 **ADOPTING RAINWATER COLLECTION INCENTIVIZATION PROGRAM**

10 WHEREAS the City Council has determined there are ongoing concerns regarding
11 potentially serious water shortage problems from impacting the
12 health, safety, and welfare of the Woodcreek community; and
13

14 WHEREAS the Texas Local Government Code, Section 580.004, authorizes and
15 encourages municipalities to promote rainwater harvesting through
16 incentives such as the provision at a discount of rain barrels or rebates for
17 water storage facilities; and
18

19 WHEREAS the City Council finds the adoption of a Rainwater Collection
20 Incentivization Program is in the public interest, and necessary for
21 promoting the health, safety, and welfare of the Woodcreek community.

24 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF**
25 **WOODCREEK, THAT:**

27 **I.**

29 The Woodcreek Rainwater Collection Incentivization Program is hereby approved and adopted
30 for purposes of promoting water preservation efforts.

34 The City Council directs City Staff to implement the “Woodcreek Rainwater Collection
35 Incentivization Program,” to the extent reasonably possible and as funded through the City’s
36 budget process for upcoming Fiscal Year 2025/2026 by establishing reasonable criteria as
37 directed by the City Council, including but not limited to eligibility and application
38 requirements.

42 The City Secretary is instructed to include a copy of this Resolution among the records of the
43 City.

47 The meeting at which this Resolution was passed was open to the public, and that public notice
48 of the time, place and purpose of said meeting was given as required by the Open Meetings Act,
49 Texas Government Code, Chapter 551.
