

**ORDINANCE NO. 22-321**  
**CITY OF WOODCREEK, TEXAS**

**AMENDMENT TO CHAPTER 32.01 OF THE CODE OF ORDINANCES INVESTMENT POLICY ORDINANCE**  
**AN ORDINANCE AMENDING THE CITY OF WOODCREEK CODE OF ORDINANCES AT TITLE III**  
**("ADMINISTRATION"), CHAPTER 32 ("FINANCE AND REVENUE; TAXATION"), SECTION 32.01**  
**("INVESTMENT POLICY"); PROVIDING FOR ENACTMENT, REPEALER, SEVERABILITY, CODIFICATION,**  
**AND EFFECTIVE DATE, AND FINDING PROPER NOTICE AND MEETING.**

**WHEREAS**, pursuant to Texas Local Government Code Section 2256, a municipality is required to adopt an investment policy by rule, order, ordinance, or resolution.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Woodcreek:

**1. FINDINGS OF FACT**

The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.

**2. ENACTMENT**

Chapter 32 ("FINANCE AND REVENUE; TAXATION "), Section 32.01 ("Investment Policy") of the Code of Ordinances of the City of Woodcreek is amended as to read in accordance with Attachment A, which are attached hereto and incorporated into this Ordinance for all intents and purposes.

**3. REPEALER**

All ordinances, resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

**4. SEVERABILITY**

Should any of the clauses, sentences, paragraphs, sections or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

**5. CODIFICATION**

The City Secretary is hereby authorized and directed to record and publish the language of Title III, Chapter 32 as amended by this Ordinance, in the City's Code of Ordinances.

**6. EFFECTIVE DATE**

This Ordinance shall be effective immediately upon its passage and the publication of caption of this ordinance as provided by law.



**7. PROPER NOTICE & MEETING**

**§ 32.01 INVESTMENT POLICY.**
